Dear Acting Attorney General McHenry:

Last week, the Department of Justice (DOJ) moved to end the prosecution of Walt Nauta and Carlos De Oliveira, President Donald Trump's alleged co-conspirators in the classified documents case brought by Special Counsel Jack Smith.\(^1\) We write to seek your assurance that you will publicly and promptly release, as soon as the Department's motion is granted,\(^2\) the entirety of Special Counsel Smith's report, which explains how President Trump came to knowingly retain hundreds of presidential and highly classified records at his Mar-a-Lago club and then deliberately defied judicial subpoenas, obstructed law enforcement, concealed evidence, and lied about his continuing retention of these classified records.

Consistent with DOJ regulations and clear precedent, your predecessor, Attorney General Merrick Garland, released, in full and without any redactions, all three special counsel reports written during his tenure: Special Counsel Robert Hur's report on President Joe Biden's possession of classified documents,³ Special Counsel David Weiss's report on Hunter Biden's tax and gun offenses,⁴ and Volume One of Special Counsel Jack Smith's report on President Trump's efforts to remain in power after losing the 2020 presidential election.⁵ The

Department's fair rationale for not previously releasing Volume Two of Special Counsel Smith's report was to avoid any prejudice to President Trump's co-defendants while the criminal case against them was still ongoing. Once the court grants the Department's motion to dismiss the case, that concern plainly becomes moot. Accordingly, the DOJ will have no conceivable basis upon which to continue withholding this essential report from the American people. Thus, we respectfully ask that you release it to the American people in that event without delay or evasion. We further request your written assurance that President Trump and Acting Deputy Attorney General Emil Bove, President Trump's former defense counsel, both of whom are listed in the Department's filing as "interested parties" in the matter, will not be invited or allowed to play any role in discussions or deliberations about the future of this report.

Based on a review of court filings by the Special Counsel, this report is expected to not only outline the evidence supporting the 40 felony counts against President Trump—demonstrating his willful concealment and mishandling of extremely sensitive national defense information—but also explain why he retained and concealed these classified documents and what precisely he intended to do with them. It is essential that the American people and Congress be given the means to understand how and why President Trump mishandled our nation's most sensitive classified information.

During her first briefing to the White House Press Corps, Press Secretary Karoline Leavitt said: "All of you once again have access to the most transparent and accessible president in American history. There has never been a president who communicates with the American people and the American press corps as openly and authentically as the 45th and now 47th president of the United States." Given that comparable reports on comparable subjects have been made public in the case of other presidents, we fully expect that, in keeping with this president's proudly proclaimed preeminent commitment to transparency and accessibility, you will publicly release Volume Two of Special Counsel Smith's report, in full and unredacted, as soon as the pending matter is dismissed.
