Dear Mr. Homan:

According to published reports, prior to serving as the Trump Administration's "Border Czar," you worked as a paid consultant for GEO Group, a major detention services provider and Immigration and Customs Enforcement (ICE) contractor that has already significantly benefited from the Trump Administration's immigration crackdown and the recent massive infusion of tens of billions of dollars into ICE. Recently, media outlets reported that you played a key role in the Department of Homeland Security's (DHS) hiring of David Venturella, a former GEO Group executive who now serves as the "No. 2 official overseeing the ICE division that manages contracts for immigrant detention centers." As Border Czar, you are responsible for implementing the Administration's policy of mass roundups and detention—a policy that depends heavily on the operators of private detention facilities, including GEO Group. However, your past work as a paid consultant for GEO Group and your involvement in the hiring of Mr. Venturella raise serious concerns about potential conflicts of interest in this arrangement.

Your February 2025 ethics disclosure states that you worked as a consultant for GEO Group's GEO Care division, which provides rehabilitation and electronic monitoring services, in

the two years prior to joining DHS.⁴ The filing, which was recently published by Bloomberg News but has not been made available for public inspection by the Office of Government Ethics,⁵ reveals that you made at least \$5,000—the minimum threshold for disclosure—for your work on behalf of GEO Group.⁶ In addition to your work with GEO Group, you also worked as a consultant for USA Up Star LLC, a disaster response company, to advise them on how to explore an expansion into immigration detention,⁷ and served as President of Homeland Strategic Consulting LLC, which provides "around-the-clock guidance and subject-matter expertise" to private companies seeking business development and contracting opportunities with state and federal governments—putting you in a position to potentially reward several of your former clients.⁸

The "One Big Beautiful Bill Act," signed into law in July 2025, allocates a whopping \$170 billion over four years for border and interior immigration enforcement, which is "more than the yearly budget for all local and state law enforcement agencies combined across the entire United States." In particular, the bill allocates \$75 billion to ICE over four years, \$45 billion of which will be used to build new immigration detention centers, including family detention centers. In ICE's fiscal year 2025 budget, at \$28.7 billion, is triple its fiscal year 2024 budget. As a commentator noted, this massive infusion of cash will create enormous pressure for ICE to rush to spend its full allocation of funds, which will likely result in large amounts of funding flowing to private contractors such as your recent former client, GEO Group. As Border Czar, you are uniquely positioned to help your former business client reap a huge windfall from the Trump Administration's spending on immigration enforcement and ICE's

massive budget. ¹³ Since taking office, you have called for expanding ICE's detention capacity to "at least 100,000 beds" in order to accommodate individuals swept up through the Trump Administration's ongoing mass deportation efforts. ¹⁴ To implement this expansion, ICE is working closely with private prison companies, including GEO Group. ¹⁵ Over the past eight months, DHS has awarded GEO Group multiple new government contracts. ¹⁶ These contracts include a 15-year contract valued at \$1 billion to provide support services for the establishment of a federal immigration processing center at GEO Group's Delaney Hall Facility in Newark, New Jersey; ¹⁷ a contract for the immediate activation of a federal immigration processing center at GEO Group's North Lake Facility in Baldwin, Michigan; ¹⁸ and a \$47 million contract to expand GEO Group's Folkston detention center in southeast Georgia. ¹⁹ GEO Group has also said that it expects ICE to issue contracts for its remaining vacant facilities by the end of this year. ²⁰

GEO Group may also benefit from ICE's plan to sharply increase the number of immigrants it surveils using GPS-enabled ankle monitors.²¹ Last month, the agency awarded BI Inc., a GEO Group subsidiary, a one-year extension to its immigrant ankle-monitoring contract.²² That decision delayed a competitive bidding process that could have dislodged GEO Group's control of the lucrative business.²³ Moreover, public reporting has indicated that ICE's plan to

increase the number of immigrants wearing GPS ankle monitors could generate hundreds of millions of dollars in added annual revenue for GEO Group.²⁴

The increasing reliance on GEO Group by ICE is particularly troubling given the well-documented history of abuse, mismanagement, and neglect within the company's facilities. Over the years, there have been reports of GEO Group facilities refusing or failing to provide essential medical care, ²⁵ as well as the presence of dangerous and unsanitary conditions and "abysmal" food within detention centers. ²⁶ Earlier this year, four inmates at the GEO Group-run Delaney Hall facility in Newark, New Jersey, successfully escaped from ICE custody after they broke through the facility's internal and external walls. ²⁷ According to immigration groups, the escape occurred following a riot at the detention facility over the food situation and other intolerable conditions. ²⁸ Similar conditions have also been reported at GEO Group's Northwest Detention Center in Tacoma, Washington. According to human rights groups, guards at the Tacoma facility "have been so overworked that they have delivered food close to midnight and have failed to provide yard time or disburse funds sent by their families to buy food, hygiene products and make phone calls." ²⁹ They also reported that detainees were being placed in solitary confinement if they complained about conditions at the facility. ³⁰

In light of these grave concerns and your past work for GEO Group, you may have an actual conflict of interest—and certainly the appearance of one—if you are participating in or influencing agency decisions or actions that could affect the spending of hundreds of millions or even billions of dollars with your former client. Accordingly, please confirm that you have recused yourself from all matters that could directly or indirectly benefit GEO Group, including through the award, writing, and execution of federal contracts.

Furthermore, as the House Judiciary Committee has broad jurisdiction over immigration issues and DHS, we request that you provide the following to the Committee no later than 5:00 p.m., September 8, 2025:

- 1. An itemized list of all Homeland Strategic Consulting LLC's clients from January 21, 2021, to January 19, 2025, including a description of the services rendered and the amount they paid for these services;
- 2. A full accounting of all financial benefits you have received from GEO Group, directly or indirectly, from January 21, 2021, to present;
- 3. Copies of all communications between you or your staff and the employees of any former consulting clients described in Item No. 2 above, from January 20, 2025, to the present;
- 4. All consultation records, waivers, ethics authorizations, or other agreements pertaining to your participation in matters involving the GEO Group or any other former client for whom you provided consulting services;
- 5. Copies of all communications between you or your staff and David Venturella; and
- 6. A copy of any communications, including emails, you have sent or received since January 20, 2025, discussing or referencing GEO Group's operations and/or federal contracts.

We look forward to your prompt compliance to these important oversight requests.
