Dear President Trump, Secretary Noem, and Acting Director Lyons:

We write to demand the Administration cease its violent and lawless attacks on the Chicagoland region. In recent weeks, the Department of Homeland Security (DHS) and Immigration and Customs Enforcement (ICE) have spread fear, chaos, and violence through extreme enforcement tactics and intolerable conditions at the Broadview Processing Center. In a shameful abuse of his role as Commander-in-Chief, President Trump has federalized the National Guard—over the objections of Illinois Governor JB Pritzker—and ordered troops to enable these unlawful and unconstitutional assaults on Chicagoland residents. These actions undermine public safety and the rule of law, and they endanger everyone who lives in and around Chicago.

For months, ICE officers and other DHS personnel have employed harsh, military-style tactics in enforcement operations in and around Chicago. These tactics have only escalated since the Administration's announcement of Operation Midway Blitz. In just the past month, DHS personnel have shot two people (one fatally) and publicly advanced self-serving narratives

that were immediately contradicted by body camera and surveillance footage,³ handcuffed an Alderperson at a hospital checking on the welfare of a constituent being detained by ICE,⁴ indiscriminately deployed tear gas in front of a public school and against civilians and local law enforcement,⁵ placed a handcuffed man on the ground in a chokehold,⁶ shot a pastor in the head with a pepper ball,⁷ thrown flashbang grenades at civilians,⁸ and raided an entire apartment complex and reportedly zip-tied U.S. citizens, children, and military veterans for hours.⁹

These events reflect a pervasive use of abusive tactics by DHS and ICE personnel against Chicagoland residents. They have ordered people to show up to ICE facilities and courthouses for routine immigration check-ins and hearings and detained them, effectively punishing them for complying with their case requirements. ¹⁰ They have detained U.S. citizens and others with legal status. ¹¹ They have snatched day laborers, children, parents, and grandparents off the streets. ¹² They have conducted numerous warrantless arrests lacking sufficient probable cause

and violating a 2022 consent decree.¹³ These tactics, which do nothing to promote public safety, are traumatizing entire communities and endangering the lives of families and children, including U.S. citizens.

ICE has funneled many of the people it detains through the Broadview Processing Center, which it has converted into a *de facto* detention facility. ¹⁴ Reports indicate the detainees are held for prolonged periods of time with limited access to food, bedding, shower, hygiene products, and communication with counsel and family members. ¹⁵ Seemingly unable to defend the horrific conditions at Broadview, DHS and ICE have abandoned any pretense of transparency, attacking journalists and refusing access to four Members of Congress in clear violation of federal law. ¹⁶ They have also doubled down on brutality, as officers have violently repressed protesters outside the facility, indiscriminately deploying military equipment, tear gas, rubber bullets, and pepper balls in a manner that has injured civilians, fueled further outrage in the community, and prompted a federal judge to issue a temporary restraining order. ¹⁷

The militarization of the Chicago area to advance the Administration's mass deportation agenda is an especially shocking and authoritarian tactic. The federal government has effectively invaded an American city, as gunmen atop armored vehicles train their sights on civilians, agents rappel from Black Hawk helicopters onto an apartment complex rooftop, and officers routinely shoot at and deploy chemical agents against civilians. ¹⁸

President Trump continues to incite and escalate the situation by attempting to federalize the National Guard against the Chicagoland residents, against the wishes of the Governor. ¹⁹ The National Guard is ordinarily under the control of state governors and not authorized to participate in domestic law enforcement activities, yet the President insists on defying the law and using the armed forces as a political prop to reinforce his assault on an American city. ²⁰ As with Los Angeles and Portland, there is no legal basis to deploy the National Guard to the Chicago area, and we urge President Trump to cease his illegal and un-American abuse of the military.

The Administration claims the mantle of law and order, yet its actions in the Chicagoland area demonstrate it is a catalyst for lawlessness and dysfunction. The city undoubtedly has its challenges with public safety, like so many communities both urban and rural throughout our country, but murders and other violent crimes have recorded historic declines in recent years. Violently abusing residents, kidnapping parents and children and disappearing them into detention facilities without access to basic necessities, and illegally deploying the military against a great American city does nothing to make anyone safer—in fact, it jeopardizes the safety and well-being of every community member.

We demand the Administration halt these attacks. The American people want a commonsense approach to public safety and immigration, not violent tactics that traumatize and destabilize communities. They want leadership, not theater. We urge you to step back from the brink and use your positions to enhance public safety, instead of undermining it.
